An accompanist will be paid \$125 per day for 8 hours of duty, \$50.00 for one-half day and \$8.00 per half hour if additional time is needed to complete accompanist services.

Travel expenses will be reimbursed using a sliding mileage reimbursement scale for total travel expenses. Motel accommodations will be provided as required. Meals will be paid in the amount of \$7.00 (breakfast), \$8.00 (lunch) and \$15.00 (dinner).
