Sight reading

Allison Peacock mentioned that there needed to be a set of directions that the sight reading judge follows because of changing rules last year. Membership agreed that sight reading rules will be pulled from the handbook and printed for the monitor to read before each band performs, a copy will be provided for the judge.

Paul Magneson will check and copy Cortez, CO sight reading rules and share them with the district so handbook may be updated in January.

Paul Magneson mentioned a new system of providing 3 ring binders with plastic sheet covers for the sight reading folders. Originals could be put in sheet covers, and taken out as needed.

The membership still expressed a want for the UIL sight reading material.

Dan Fear motioned that we buy our own set of UIL sight reading music soon, 2nd Rich Worchester, passed by membership
