- o Handbook change for Large Group Festival Rules under Choir Music Selection: Selections from pop genres (pop, Broadway, jazz, etc.) are discouraged. Performing songs from these genres will result in the lowering of the final score by one rating level.
- o Handbook change for Large Group Festival Rules under Choir Operating Procedure: All choirs that perform at the District Large Group Choir Festival will be given the option to sight-read or have a half an hour clinic with one of the judges. We need to eliminate the following sentences: The choir's overall rating will be lowered by one level if a choir does not sight-read. Judges comments will be held back from "for comment only" choirs that do not sight read.
- o Handbook addition for Large Group Festival Rules under Choir Operating Procedure: Choirs that choose to be rated will be given a numeric score that takes the average of all of the judges scores.
