- Summer Music Educators Workshop

• New Customer Relationship Management System

As you probably know, NAfME has rolled out a new Customer Relationship System (CRM). This is the platform that keeps membership records and allows members to log into the NAfME and NMMEA websites. We are currently working to install updates to our website so that our website can access the new national database and members can log in. This work should be finished in the next week of so.

• State Contest Adjudicator Submission Form

There is a form available online for all members to submit names to be considered as adjudicators for the NMAA State Choir and Band Contests. Names will be reviewed and ranked by the Contest Advisory Councils. Please take a few minutes and nominate qualified out of state judges.

• <u>Update Vendor Information</u>

Please make sure that your school / school district has updated their list of vendors to include the new mailing address and contact information for NMMEA. Most districts will need an updated W-9 to do this, please contact me via email and I will get one to you. Please do not wait until you are signing up for auditions to do this!

Handbook

Please review the online handbook for the latest updates and etc. It is each director's responsibility to make sure they are following the proper procedures and guidelines

Membership

In order to sign students up for auditions and events, each participating director must be current on their membership. Please make sure that you do not let this lapse as it could possibly cause you to miss registration deadlines. Memberships can be renewed directly through the NAfME website.

• All-State Audition Registration

Please make sure to check the website regularly and meet all registration deadlines.

Make sure to submit complete and accurately spelled names.

Make sure that you submit first and last names in the correct field and not reversed Students must declare their preference at the time of registration if they are auditioning for more than one ensemble. It is the responsibility of both directors to communicate and agree on the preference of the student and submit the same preference.

You are only allowed to sign up students that are in your ensemble. Do not sign students up for another teacher (choir teacher signing up band students for the band director and etc.).

Deadlines for Band Auditions

- October 4, 2019 Close of Band Auditions
- October 11, 2019 Late Registration Closes

Please register your students early so we have time to problem solve in the event you have login problems.

- O Students must be enrolled in the like ensemble at the high school where they are enrolled. For example, a student may not audition for All-State Orchestra if they are not taking orchestra at the high school (even if they are enrolled in Choir). Please check handbook for exact wording. Talk with Neil for scheduling conflicts and other issues.
- O Teachers may only enroll their own students. For example, the choir director may not enroll band students for all-state auditions
- O Home school students and students attending schools without music programs must contact me for directions how to register for auditions. Please do not add them to your list. This registration is a different process and requires different documentation.
- O Please, please, please...double check student spelling before submission! Once the names are submitted for an audition registration they will appear in the program (and shirt) spelled this way. The only way to correct this is for you to send an email to me and for me to manually correct the spelling. There is a huge chance of error at this point as I will have multiple documents that will need to be updated.
- O And Please (x 100) make sure that you enter student first and last name in the correct column! This is a huge issue if this is done incorrectly!
- O If you have a student that is auditioning for 2 All-State ensembles (for example guitar and choir), you must speak to the other director and the student to determine what that student's preference is and then both directors must submit the same information. For example, if Ludwig is auditioning for Choir and Orchestra, both the choir and orchestra director should meet with Ludwig and find out what his preference is. If his preference is Orchestra, then both the choir and orchestra director must mark orchestra as his preference. This must be done at the time of registration...not later. In the past we have had the orchestra director say Ludwig's preference is orchestra and the choir director say his preference is choir. This becomes an issue, so please communicate when signing students up!
- O Please only request a special audition time for serious conflicts as we can't accommodate everyone's wishes. For example, stating you would like to go in the morning so the students only have to miss their music class isn't a valid reason.
- o If paying by PO, I must have the PO before students will be scheduled for an audition
- o If paying by check, I must have the check before students will be scheduled for an audition
- O Please make sure your business office has an updated W-0 for NMMEA. The updated version has my contact information (4540 Giddeon Truesdell, Silver City, NM 88061). If you need a copy, please email me.
- O RENEW YOUR MEMBERSHIP BEFORE COMING TO ALL-STATE
 - o Registering people on site for NAfME to be able to participate in All-State took time and resources away from people who had planned ahead. Please plan accordingly.

 - Remember to have your students and parents fill out **before** the auditions. These are to be held by the director and referenced if any issues arise concerning that which is stated on the form.
