





Efficient communication is the backbone of our organization. The Executive Committee and Board of Directors make every effort to keep members informed about events and processes. Please check the website regularly as this is one of our main communication resources.

While visiting the website, please make sure to review the handbook as there were several changes made during the spring meeting. It is the responsibility of each member to review this important document and make sure they are following processes and procedures.

Audition information for All-State 2023 will be posted on the website by April 1st. Please make sure to review this information and share it with your students. Also, please check back regularly for updates on material and other important audition information.

Just a few important reminders regarding auditions:

1.

A taskforce met after last fall's auditions to review OpusEvent and make recommendations on how to improve the process. Many great ideas were shared and will be implemented. Please look for that information in early fall.

Directors must be members in good standing at the time of audition registrations, so please plan and renew your memberships early! NAfME must receive a check before they activate your membership, a PO on file with them will not suffice.

3.

Make sure to register students accurately. Each year several members

register students with first and last names reversed. Make sure to enter them correctly and always double check spelling.

4

If a student is auditioning for multiple ensembles, a preference must be declared at registration. Directors, please communicate with your colleagues to ensure that the same information is entered for each entry. This may seem like a small issue, but at the time of results it is a huge issue. Thank you for making this a priority.

5.

Make sure your students understand the audition process and have audition details in a timely manner.

6

Watch the audition deadlines as once the late deadline passes no students will be added!

7.

All homeschool students must register directly through me.

8.

In order for you to register a student, they must be members of your ensemble. Do not register students for a colleague – they need to register their own students.

9.

Once you have completed the registration process, please check your email for a conformation and make sure all were entered correctly. Once the deadline passes it is impossible to add students left off the original registration.

10.

And finally, please make sure I receive payment (check, credit card or PO) immediately after you register.

As you look forward to summer break, I would like to remind you of a few things.

Membership renewal

Please remember to check your membership expiration date and take care of renewing in a timely fashion. Please renew directly with NAfME.

#### Office Notes...

Remember that your membership will not be activated until NAfME receives a check, so it is important to start the process early.

Membership accuracy

Please take a few minutes and log into NAfME and check your contact information. I regularly download the membership database and use this to mail or email members, so please check that your contact information is correct.

### Editor's Desk Keith Jordan



Dear Music Colleagues;

The NAfME Public Policy Team has recently published three articles on federal funding for education and how it affects music education.

# 1. FY 2022 Bipartisan Omnibus Agreement

On March 9th the House of Representatives passed an omnibus spending bill, the Senate passed the spending bill on the following day, and President Biden signed the spending bill on March 14th. The FY (Fiscal Year) 22 spending bill was passed in the wake of contention between the parties on Defense vs. Non-Defense spending. For the two parties to come to an agreement before a government shutdown took place on Friday, concessions had to be made. The FY 22 spending bill passed by Congress includes a \$2.3 billion increase to Department of Education funding (\$2.9 billion including the Pell grant), bringing the total ED funding amount to \$53.9 billion. Details below:

Title I, Part A— The largest source of federal funding for schools in poverty and economically disadvantaged students. Title I-A is set to be funded at \$17.5 billion, a \$1 billion increase over FY 21 funding. This proposed increase to Title I-A would allow for an increased level of supplemental support in providing a well-rounded education that includes music. Title II, Part A-Funding for the

professional development of teachers and school administrators is also set to receive an increase in funding. Title II-A is set to be funded at \$2.2 billion, a \$27 million increase from FY 21 funding. Title II, Part A funding can be used to support recruitment and professional development of music educators.

Title IV, Part A— Title IV-A provides block grants for three express purposes, one of which is to support a well-rounded education for students. Through these block grants, Title IV-A is the federal funding stream most commonly used for providing supplemental instruction for music and arts education. Title IV-A is set to be funded at \$1.28 billion, a \$60 million increase over FY 21 funding.

#### **Build Back Better**

As part of his "Build Back Better" framework President Biden has proposed several policies to expand opportunity for historically disenfranchised groups. As it pertains to education, President Biden has proposed three policies that fall directly in line with NAfME's goals of expanding student access to music education.

Make a historic investment to support students in high-poverty schools.

To ensure that every student—including those from underserved and under-resourced communities—can learn and thrive, the FY 22 budget provides a \$1 billion increase to Title I grants. This new funding is meant to provide under-resourced schools with the funding needed to deliver a high-quality education to all of students by ensuring teachers at Title I schools are paid competitively, providing equitable access to a rigorous curriculum, increasing access to preschool, and providing meaningful incentives for states to

examine and address inequalities in school funding systems.

Boost Support for Children with Disabilities

As part of his "Build Back Better" framework, President Biden's budget includes \$13.3 billion (a \$406 million increase from FY 21) for the Individuals with Disabilities Education Act (IDEA). IDEA supports special education and related services for over 7.6 million Pre-K-12 students.

Prioritize the Physical and Mental Well-Being of Students

The physical and mental well-being of students has been shown to have a profound effect on their academic achievement. To this end, President Biden's budget provides \$75 million (a \$45 million increase from FY 21) for full-service community schools to provide comprehensive academic, social, and health services for students, students' family members, and community members that will result in improved educational outcomes for children.

#### 2. Changing the Rule: How the Change in the "Supplement Not Supplant" Provision Can Help Support Music Education

Title I, Part A of the Every Student Succeeds Act (ESEA) seeks to provide funding to ensure that all children have a fair, equal, and significant opportunity to obtain a high-quality education. Historically, these funds have been used to provide a host of services such as intervention specialists, tutoring, materials, and print resources to support students' academic growth. Although the use of Title I funds varies between schools and school districts, the hurdle to broadening the use of

these funds for music education is in part rooted in a provision known as "Supplement Not Supplant" (SNS).

The SNS provision worked to ensure that Title I, Part A funds would be used as a supplemental resource; not a replacement of funding that would have otherwise come from local and state sources. In collecting feedback relating to the SNS provision and compliance process, the U.S. Department of Education (ED) found that those responsible for implementing the provision felt that it was a restrictive process. An unintended consequence of this process was that LEAs and schools did not have the flexibility to implement new spending avenues, because Title I-A funds must supplement an already existing program.

After receiving public input on the SNS provisions, the compliance process went through a change to provide more flexibility to meet student needs. In 2019, the U.S. Department of Education created an informational document entitled "Supplement Not Supplant Under Title I, Part A of The Elementary and Secondary Act of 1965 as Amended by Every Student Succeeds Act." The document highlights the history of the SNS provision and shift in the compliance process to what is now called "Title I neutral" funding methodology. According to the document, a Title I neutral funding methodology does not consider federal funds when LEAs are determining the allocation of state and local funds. With this funding methodology, funds provided through federal sources would therefore be supplemental. As a result of this shift, LEAs are no longer required to provide how the usage of Title I funds are supplemental, thus allowing for a broader avenue for spending opportunities, including music education.

Although the change in compliance

could allow for flexibility in spending, opponents are concerned that this could mean less oversight of federal funding at the state and local levels, which could increase inequitable spending for students. These advocates sought to have LEAs provide a basic per pupil spending formula to ensure equitable funding across a district. The Title I neutral funding formula does not require LEAs to identify a per pupil formula nor provide information regarding if additional funding are being provided for special programs such as magnet school or school with high populations of advanced learners.

Music education advocates must be aware of potential hurdles when advocating for the use of Title I funds for music education. One of those hurdles is providing an explanation as to how funds spent on music education can support either a schoolwide or targeted assistance program that upgrades the educational environment for students. Another hurdle may be navigating the process of educating administrators and federal grant managers, as they may be operating under the older version of allowable spending opportunities.

When music education advocates seek to advocate for Title I funds to be spent on music education, it would be helpful to align funding asks with overall schoolwide or district wide goals. Along with aligning funding asks, advocates should prepare to have multiple conversations with administrators to educate them on music education being an allowable use of federal funds. ## 3. Title I and Music Education: Allowable Uses

The purpose of the Title I, Part A program under the Every Student

Succeeds Act (ESSA) is to provide "all children significant opportunity to receive a fair, equitable, and high-quality education, and to close educational achievement gaps." (Sec. 1001) Throughout its implementation, Title I funds have been a valuable resource to fund opportunities for student growth. However, well-rounded subject areas such as music education experience limited or little access to Title I funds.

The "Supplement not Supplant" Provision

The Title I program contains a provision known as "supplement, not supplant," which requires that federal funding meant to support low-income students must be used in addition to, not in place of, state and local funds. The previous "Supplement not Supplant" provision was changed in 2019 by the U.S. Department of Education (ED) to allow for more flexibility in the use of Title I funds. The previous restrictive compliance process has shifted to a broader use of funds based on a funding methodology called "Title I Neutral." The new guidance outlines how ED will determine whether local educational agencies (LEAs) have supplanted state or local funds with Title I, Part A funds. Under ESSA, an LEA's allocation of state and local funds to schools is examined to ensure that Title I, Part A funds supplement, and do not supplant, state and local funds. In other words, ED cannot require an LEA to identify whether any individual cost or service supported with Title I, Part A funds is supplemental. This provision applies to all Title I schools, including schoolwideprogram and targeted assistance schools. It also applies with respect to Title I resources not allocated to schools.

Supporting student growth by utilizing Title I, Part A funds that target and enrich music education experiences varies depending on th

student growth; however, this is only a selection of examples. School administrators, music educators and advocates are encouraged to discuss other funding opportunities to support the needs of students that may not be listed below.

  Title I neutral funding methodology

Title I neutral funding methodology is when an LEA does not consider federal funding when allocating state and local funds. Therefore, when LEAs do not include fed-

Please note that all required tempos of the etudes are included in the audition list, some of which may be different from what is printed in the etude books.

Reminder: Small School and Large School audition excerpts are the same; and students must specify which ensemble they are auditioning for.

Registration is done electronically online with students required to sign a commitment form. Directors will need to make sure that they have validated and collected all signed commitment forms when they register their students. Directors will not turn in forms to the state but will keep them on file for one year.

Our audition window will now be longer! Neil Swap created a task force of diverse educators to facilitate any issues with our adoption of Opus Events. The benefits of submitting online versus in person is truly priceless, but we know that we still have room for improvement. The task force (and approved by the board), found that having weekends for audition submissions would really help directors who have chaotic schedules during the week. We also invite you to reinvent how you go about auditioning your students. One excellent idea that was mentioned was having a day where all of your students come in and record and submit their scales and excerpts, and come in at a later date to perform their solo and sigh-reading. We no longer have a set "audition order," you can have students record as much and in whatever order they want. The judges will listen to each recording in which ever order they see fit. This has also been updated in the Handbook found in our website. We will continue to have videos that demonstrate how to register, submit, troubleshoot, and will be going over those details at future Town Hall meetings. The extended time will also aid in troubleshooting any issues and possible less stress about re-do's. Here are the details: 2023 Audition Window - October 24th to November 6th, Rosters posted as early as November 15th (could be later depending on adjudicators and number of auditions).

Your audition team is:

-Violin: Stephanie Meyers

-Viola: Kimberly Fredenburgh

-Cello: Joel Becktell

-Bass: George Nicholson

Audition timings: We will be using the following timings for each component of the audition material. We will be adding extra time in Opus Event to allow students time to start and to fully play the selected material at tempo:

Scales:

-Violin, Viola, Cello scales time limit is 45 seconds per 3 octave scale, 90 seconds total

Bass scales time limit is

#### Orchestra Section...

30 seconds per 2 octave scale, 60 seconds total.

Excerpts:

- Excerpts time limit is 1 minute per excerpt, 2 minutes total. Solos:
- Solo time limit is 3 minutes Sight-Reading
- Sight-reading time limit is 30 seconds to study, 30 seconds to perform, 1 minute total.

  These timings should allow the

judges to make a confident scoring. A few more things to consider are that Opus Event will be preprogrammed with the timings (extra time is added) and will cut the students off once the pre-programmed time has finished. If a student plays any component at a slower tempo, they might not fit everything in the time limit. The solos are usually the component where students are cut off but we do feel that three minutes gives the judge everything they need to make a decision. It is okay if the student does not play the entire solo as stated in the audition materials list, but hopefully the majority of the solo has been performed.

Lastly, a note about multiple rests: If

there are multiple measures of rests, students shall take one full measure of rest, then proceed to perform. 2023 Orchestra Conductors:



Dr. Michael Walker, Associate Professor of French Horn, announces the upcoming release of The Amity Trio's debut album, "Between Us Now," in April 2022. The trio's members are Katie Dukes (soprano), Michael Walker (horn) and Kimberly Carballo (piano), and the recording will feature works by Dr. Lauren Bernofsky, Dr. Alice Jones, Dr. Carrie Magin, Amy Beach, Nur Slim and Florence Price, with album artwork to be created by Wyatt Pottorff. The album will be available on Apple Music and at the trio's website: www.amitytrio.com. The ensemble was founded in 2018 to promote music by living composers and perform music by underrepresented composers, and they often collaborate with composers to create new music that they share with audiences through their concerts and performances in traditional and nontraditional venues.

Dr. Kristina Jacobsen, Associate Professor of Ethnomusicology, has been busy writing, performing and presenting her research. Together with Sardinian ethnomusicologists Marco Lutzu, Diego Pani and Ignazio Macchiarella, she presented her research on a panel at the conference in Cambridge, England, on "Women and Creativity in Sardinia." Her album, House on Swallow Street, written and recorded while living in Sardinia, was released in Italy in February 2021, and has been favorably reviewed and featured on radio stations, podcasts and newspapers across Italy. Recently, the album was reviewed for the first time in the Sardinian language, a politically non-dominant language she was studying while she lived in Sardinia as a Fulbright Scholar. On November 6, Dr. Maxine Thévenot, Instructor of Organ, conducted the cathedral choir, soloists, and orchestra in the New Mexican premiere of Joseph Martin Kraus' Requiem as part of the Concert of Remembrance held at the Episcopal Cathedral of St. John in Albuquerque. The performance featured concertmaster Stephen Redfield, soloists Sarah Nickerson (mezzo), Hayden Eberhart (soprano) and Edmund Connolly (baritone) and included UNM faculty members Dr. Michael Walker (French horn) and Megan Holland (violin). The program also included String Quartet #5 by Joseph Boulogne, Kaddish from Deux Mélodies Hébraïques by Maurice Ravel, sung by music department faculty member Jamie Flora (tenor).

On December 11, Dr. Thévenot performed a concert on the recently restored Frederick R. Haas Pipe Organ in the St. Francis Auditorium in Santa Fe. The concert was attended by 350 people in the historic audito-

rium of the New Mexico Museum of Art. The concert marked the return of the pipe organ, which has not been played publicly since 2014 and was recently refurbished in 2021, thanks to a generous donation from the Philadelphia-based Wyncote Foundation and foundation trustee Frederick R. Haas.

In December, Scott Ney, Associate Professor of Percussion, did a weeklong tour in Michigan, where he presented clinics at the University of Michigan and Interlochen Center for the Arts, and was invited by Dr. Mark Stone to visit Oakland University for their fall World Percussion concert. On December 17, he performed the world premiere of Hometown to the World by Laura Kaminsky and Kimberly Reed with the Santa Fe Opera.

#### In Memoriam

It is with great sadness that we report the passing of our colleague and friend Prof. Eric Rombach-Kendall, after suffering a major heart attack on January 24th at the age of 64. Eric was Director of Bands at UNM since 1993. He was president of the College Band Directors National Association from 2011 to 2013 and had served on the Albuquerque Youth Symphony board from 2015 to 2018. Prior to coming to UNM he was Band Director at Boston University (1989-1993) and Carleton College in Northfield Minnesota (1988). He held a Bachelor of Music from the University of Puget Sound and two Master of Music degrees from the University of Michigan-Ann Arbor. He is survived by his wife, Julie Rombach-Kendall, daughter Rebecca Kendall and son Michael Kendall. A memorial service was held on Sunday, February 20th, in the prayer garden of St. John's United Methodist Church.

We also regret to report the recent passing on December 22 of beloved

Professor Emeritus Scott Wilkinson at the age of 99. Scott received his bachelor's and master's degrees from the University of Arizona and did advanced studies in composition under Darius Milhaud at Mills College in California, and then at Milhaud's home in Paris, France. Scott worked briefly in documentary and educational films in New York City before becoming Managing Editor for the music publishing company Carl Fischer, Inc. In 1961, he and his wife Linda settled in Albuquerque and opened The Music Mart. In 1968, Scott sold the store and subsequently accepted a position in the Department of Music at UNM, where he taught Theory and Composition and became coordinator of the Theory program. During his tenure, he assisted in coordinating the UNM John Donald Robb Composers' Symposium, an annual event that draws major composers both nationally and internationally, and is credited with influencing Dean Robb to leave his archival materials to UNM rather than to Yale or Harvard. Composition was Scott's major interest for most of his career, and he published works in a variety of media. In 2020, the Robb Trust presented him with The Robb Award for Excellence in Music.

# NMSU MUSIC DEPARTMENT NEWS

Classical and Jazz pianist, Willis Delony gave a guest recital at NMSU on Wednesday, February 2. He also worked with NMSU pianists in a masterclass while on campus and gave a performance with the NMSU Jazz Combo.

The Reveron Piano Trio gave a recital on Saturday, March 19 at 7:30 pm. The trio showcases underrepresented music from Latin America while also performing standard repertoire and new music.

#### Winds and Percussion

The 39th Annual Southwest Honor Band Festival took place on February 2-6, 2022 with more than 200 students from New Mexico, Texas, Arizona, and California. Coordinated by Dr. Michael Mapp, this year's festival featured clinicians Dr. Carolina Beatty, Director of Bands at Texas State University, Dr. Mark Norman, Director of Instrumental Ensembles at North Carolina School of the Arts, and Dr. Jason Nam, Assistant Director of Bands at Indiana University.

As part of the festival, students attended masterclasses given by all NMSU Wind and Percussion faculty, as well as performances by Desert Winds, led by Dr. Steven Smyth and the NMSU Wind Symphony, under the direction of Dr. Michael Mapp. The Wind Symphony concert featured, among other things, Ecstatic Waters by Steven Bryant.

On Sunday, February 20, 2022, the NMSU Jazz Ensemble gave a concert at First Christian Church in Las Cruces. This performance was given in conjunction with the Mesilla Valley Jazz and Blues Society and was titled "Ornithology: A Concert About Birds for No Particular Reason."

On March 1 the NMSU Wind Sym-

phony and Symphonic Band gave a joint concert. The Symphonic Band performed Charm by Kevin Puts, Serenity by Ola Gjeilo, Primula by Yukiko Nishimura and Pete Meechan's Perpetua. The Wind Symphony portion of this evening also served as the final conducting recital of Masters of Music in Conducting student, Amanda Poland. Ms. Poland conducted Smetana Fanfare by Karel Husa, Heart's Lullaby by Brooke Pierson and her own arrangement of Andreoméde by Augusta Holmés.

On April 10 we will host the first ever NMSU Jazz Studio Orchestra concert, presenting Oliver Nelson's The Kennedy Dream. The Jazz Band will also perform as part of the Organ Mountain Jazz Festival on April 27th.

The Wind Ensemble will give a concert on April 26th featuring Visiting Trumpet Professor, Jacob Dalager, on his own composition, Organ Mountain Fantasia. In addition to this, the Wind Ensemble is preparing for their invited performance in Prague, Czech Republic this July as part of the WASBE Fringe Festival.

#### **Strings and Orchestra**

On Saturday, December 4, 2021 the NMSU Philharmonic Orchestra performed a joint concert with the Las Cruces Youth Orchestras. There were performances by small ensembles, as well as all of the Youth Orchestras and the Youth Choir.

The Southwest Honor Orchestra Festival was held February 25-26, 2022 and involved students from Las Cruces, Centennial, Mayfield, and Alamogordo High Schools, as well as La Asociación de Amigos de la Orquestra Sinfónica Esperanza Azteca A.C from Ciudad Juarez, Mexico. The students received masterclasses from NMSU String Faculty members and performed a concert alongside the NMSU Philharmonic Orchestra, under the direction of NMSU Associ-

ate Professor of Violin, Simon Gollo. The program was dedicated to dances and included Hungarian Dance No. 1 by Brhams, Danza Española No. 1 by Manuel de Falla, and Emperor Waltz, Op. 437 by Johann Strauss.

#### **Choral & Vocal**

On December 3, 2021 the Combined NMSU Choirs presented their Winter Concert. Included in this performance was Sarah Quartel's extended work, Snow Angel, in collaboration with members of the NMSU Theater department and guest artist, Dr Hyerim Mapp on cello. The NMSU Combined Choirs also presented a concert on March 25, 2022 titled, "All Worlds, All Natures." It featured works celebrating our vibrant, yet vulnerable world. Donations were collected in support of local environmental organizations.

#### **Faculty News**

Assistant Professor of Viola, Jorge Martinez-Rios has been very active! He gave a chamber recital on February 19, 2022 as part of the NMSU Faculty Concert Series featuring guest artists from Lincoln Center and Carnegie Hall. Martinez-Rios performed a recital at The Tobin Center in San Antonio, TX on March 5 and gave another chamber recital as part of his Organ Mountain Music Academy on March 16. His new album, "XX Century Works for Viola" featuring music of Mexican composers, was released on April 1, 2022.

Jorge Martinez-Rios, Cello Professor Jorge Espinoza and Voice Area Coordinator Dr. Sarah Daughtrey have been invited for a week-long visit to the Conservatorio de las Rosas in Morelia, Mexico for master classes and a faculty recital. This visit is a continuation of the exchange between the Conservatory and NMSU, which earlier featured virtual master classes by faculty with students at the conservatory.

Dr. Daughtrey's new album on Centaur Records, "Touch of Blue" was released in March. The album, featuring Elizabethtown College (PA) collaborative piano professor Dr. Justin Badgerow, along with Lubbock-based saxophonist David Box,includes works for the unusual combination of voice, saxophone and piano, including NMSU Theory Professor, Lon W. Chaffin's song cycle "Blue Diminuendo," written for the trio. Dr. Daughtrey also recently presented at the College Music Society's Southwest Conference at Azusa Pacific University in California, again based on her article for the NATS Journal of Singing on teaching Generation Z, this time focused on studio teaching for all instruments.

On January 15, 2022, Low Brass Professor, Dr. Allan Kaplan presented a masterclass titled: "Tabuteau for Trombone" at the Big 12 Trombone Conference, which was held at Texas Tech University.

Assistant Professor of Clarinet, Dr. Madelyn Moore was awarded \$10,000 from the NMSU College of Arts and Sciences to fund the commission of three new works for flute and clarinet alone. This will serve as the genesis for a long-term project that will involve several new chamber works inspired by the US National Parks System, and will launch a series of recitals and recordings.

The NMSU Brass Quintet, consisting of retired Professor of Trumpet, Poncho Romero, Visiting Assistant Professor of Trumpet, Jacob Dalager, Professor of Horn, Nancy Joy, Low Brass Professor, Allan Kaplan, and Music History Professor, Jim Shearer, has been actively touring Albuquerque, Las Cruces and El Paso since early December. They also gave a recital on campus March 17.

All of this was in preparation for the Mock Orchestral Audition that took place on March 21.

Following her excellent senior recital on January 14, trumpet player Kali Ivy is preparing for a performance as part of the International Women's Brass Conference's Susan Slaughter Solo competition. This competition will take place in May.

Senior Vocal Music Education Major, Priscilla Gandara has been selected to perform in an opera production in Salzburg, Austria this summer. She will sing the role of Marcellina in Le Nozze di Figaro in July of 2022 as part of the Austrian American Mozart Academy.

Violinist Sahid Palacios was awarded first price at the Music Guild of New Mexico's Jackie McGehee Young Artists' Competition for Piano and Strings. The award includes \$2,500 and the opportunity to perform with the New Mexico Philharmonic.


