

# Minutes for the Choral Section of NWNMMEA Meeting May 2024

- Called to Order at 9:10 am
- **Financial Report**
  - There is \$ 7591.47 in the choir account. But we are missing 7 payments totaling \$1540. We should have \$9131.47 in our account when all payments are received.
- **High School & Middle School Solo and Ensemble**
  - When: **Sept. 28th, 2024 Saturday**
  - Where: **FHS**
  - **Choral VP** will get the judges. (Make sure the judges fill out a clinician contract and W9 form and it is given to the choir secretary.) <https://www.nmmea.com/wp-content/uploads/2014/07/Choir-Adjudication-Contract.pdf> )
  - Registration by **Sept. 14th, 2024**. Please register on the NMMEA website <https://www.nmmea.com/districts/northwest/entry-forms/> (Siromani will need to invoice everyone once registration is completed)
  - Fee is \$10 per student per ensemble/song (If you register the student, they need to pay regardless of showing up to the event)
  - This event is great for All-State solo practice.
  - May use a track as accompaniment.
  - Types of songs: Art, Jazz, Broadway, Folk. No Pop or Country songs.
  - It is recommended that one legal copy of the music is on hand for the judges.
  - Students, please stay true to the printed page of music.
  - Small ensembles are encouraged to sing non-unison pieces.
  - Students need to be prepared with their accompaniment track on CD, flash drive, or phone (if using an Apple phone please make sure they have a dongle/adaptor.)
  - Teachers **MUST** attend with their students.
  - Schedule requests/changes need to be communicated as early as possible.
  - Sight-Reading component - heavily suggested for the High School students who will be auditioning for All-State Choir. Two teachers needed to help facilitate this. Once a student finishes with their solo they will go line up for a quick 10-minute sight-reading example and clinic.
- **Honor Choir for 7<sup>th</sup>-9<sup>th</sup> Grade Mixed Choir & 6th Grade Treble Choir**
  - **Wrap-up: What went well, what do we want to change?**
    - It was very short!
    - Students **MUST** be prepared. An idea to help with this is to use two of the pieces in your own fall concert so students don't have to learn as much outside of class.
    - Concerns about the venue/security guard.
      - If the venue is in Farmington there will likely be more audience members.
    - Possibility to add a treble choir.
    - Possibility to add 6th grade treble choir.
  - **We made \$64.77 for the Honor Choir event. We basically spent as much as we raised. And we didn't pay for an accompanist. If we did, we would be in the red.**
