The New Mexico Music Educators Association (NMMEA) is extending an invitation to businesses to become an All-State Concert Sponsor for our eight All-State ensemble concerts. These concerts will take place on **Saturday, January 9, 2027**, at Popejoy Hall on the University of New Mexico campus. The concerts will be presented in three separate blocks, and we would be delighted to have you as one of our concert sponsors for the 81st NMMEA All-State.

By becoming a sponsor, you will not only support the top music students in New Mexico but also gain visibility for your business. Sponsors will have the opportunity to place a color ad, approximately 3.5” high x 6” wide, in our digital program. These concerts draw an audience of over 3,000 people from across New Mexico. Additionally, sponsors will be acknowledged at the beginning of each of the three concert blocks and will receive two conference badges. No additional amenities are included.

Booth

In addition to the benefits of concert sponsorship, businesses have the option to reserve one 8-foot booth, which includes a table and a backdrop curtain, for a cost of \$750. This booth provides an opportunity to engage with attendees and promote your products. The booths will be in the foyer area outside Keller Hall. Please note that space is very limited and will also be offered to our state universities, so act early. If the sponsorship is shared, the purchased table will also need to be shared.

Booths are to be staffed on **Wednesday, January 6, 2027, from 3:00 PM to 9:00 PM and on Thursday, January 7, 2027, from 8:00 AM to 5:00 PM**. Due to the multiple access points to this high-traffic area, NMMEA will not be providing security. We recommend that you remove any valuable items on Wednesday evening when you leave and set them up again on Thursday morning.
